

Touring & Camping Booking Conditions

We want everyone to enjoy their stay on our parks but ask that you read the conditions below before making a booking.

Our prices are inclusive of VAT and are for 1 unit, 2 people & 1 car per night.

Maximum of 7 people per pitch, including children.

All regular bookings require a minimum £30 deposit. All bank holiday bookings require 4 nights minimum stay and must be paid in full at time of booking. Single night bookings may be available during off peak times.

Deposits are non refundable after a booking has been accepted, however, we are happy to transfer your deposit to an alternative booking if notice is given (not applicable to bank holiday bookings). Pitch fees will not be refunded due to inclement weather.

We are a family park and reserve the right to refuse single sex groups as well as groups of young people.

Pitches are available from 11am onwards. New arrivals must check in before dusk.

Please vacate your pitch no later than 11am unless a 'late stay' has been agreed.

We cannot guarantee a specific pitch but will endeavour to put you in the area of your choice and keep families together.

Maximum tent size (including guide lines) a pitch can accommodate is 6m x 6m.

Please be aware that visitors staying in the 'Meadow' at Channel View are required to cross a public road to access the facilities.

Sleeping in cars is not permitted.

A strict 10mph speed limit applies on the park at all times.

Please respect other park visitors and keep noise to a minimum after 10pm.

No commercial, converted or sign written vehicles are permitted on the park unless by prior arrangement with the management. Please phone us if you are unsure whether your vehicle falls into this category.

Only caravans and motorhomes are permitted on the sea view pitches at Channel View.

One awning annex is permitted per pitch with the exception of Channel View standard pitches where no annex is permitted.

Pets must be kept on a lead at all times and not allowed to foul on the park or annoy other park users. Dogs staying on Channel view can be exercised on the beach or at Westbrook Farm, in the dog walk area. Please do not leave pets unattended for long periods of time. We reserve the right to refuse admission or eject from the park any dog which we consider inappropriate for a family park. Maximum of 2 pets per pitch.

No hard ball games on the parks. At Westbrook Farm all children must be accompanied whilst using the play area.

Chinese lanterns are strictly forbidden.

Only grass friendly groundsheets are permitted and windbreaks must not obstruct the thoroughfare between caravans.

Gazebos are permitted at the Warden's discretion and weather permitting.

No external generators.

We are happy for you to use barbecues, we only request that they are raised off the ground to prevent damaging the grass.

Please do not flush wet wipes, (including flushable wipes) babies nappies or sanitary items down our drainage system.

Portable toilets must be emptied in the designated disposal points only, located by the toilet blocks.

No clothes lines please, window racks are permitted.

Channel View/Westbrook Farm cannot accept any Liability for personal injury, inconvenience, damage or loss to persons or property however caused whilst on the park. All units must be insured for public liability.

We reserve the right to refuse admission.

The management reserves the right to terminate the booking of any person/s at any time whose conduct is detrimental to the park or the comfort of other visitors. Offenders will be asked to leave the park immediately and no refunds will be issued.
